**Subject: Regarding modification of Qualification Criteria and revision of ‘Calendar of Events’.**

a. Clause no. 1.7 ‘Qualification Criteria’ has been amended as given below:

1.7.1	The Bidder should be either registered as a Company under Companies Act 1956/ 2013 or as a Partnership (including Limited Liability Partnership) under Partnership Act, 1932.	This clause has been excluded.
1.7.2	The bidder should have a cumulative Trenching and /or OFC cable Overhead laying experience for at least 100 km anywhere in India. PO copies along with completion certificate to be submitted in this regard.	The bidder should have a cumulative Trenching and /or OFC cable Overhead laying experience for at least 100 km anywhere in India.  PO copies / completion certificate / Invoice to be submitted in this regard. In case the bidder is an ISP, self-certification of executed quantity along with purchase invoices and License issued by DoT shall be submitted.
1.7.3	The bidder should have average annual turnover of minimum of Rs. 8 Crore for three financial years out of five Financial Year (FY 18-19, FY 19-20 FY 20-21, FY 21-22, FY 22-23). Copy of audited Balance Sheet and P&L Account to be submitted in this regard. For MSME registered in the State of Odisha, criteria shall be reduced to 20% of the existing one.	No change. Same clause shall be applicable.
1.7.4	The bidder should have executed similar SITC works for cumulative order value of Rs. 3 Cr. for a single order or Rs. 1.5 Cr. for 2 orders each or Rs. 1 Crore for 3 orders each during last 5 years only pertaining to installation testing Commissioning of OFC or above. PO copies along with completion certificate to be submitted in this regard.	The bidder should have executed similar SITC works during last 5 years for cumulative value of Rs. 3 Cr.  PO copies / completion certificate / Invoice to be submitted by bidder in this regard. In case the bidder is an ISP, self-certification of amount of OFC laid, along with purchase invoices of OFC and License issued by DoT shall be submitted.
1.7.5	Bidder should be a company registered in India with an office in Bhubaneswar/Cuttack or any local tie up with Firm presence in Bhubaneswar/Cuttack. Bidder should submit the undertaking and details of address in this regard.	No change. Same clause shall be applicable.
1.7.6	The bidder must have all statutory compliance like valid PAN no, GSTN etc. The bidder must submit the copy of all these registrations.	No change. Same clause shall be applicable.
