Subject: Regarding modification of Qualification Criteria, revision of ‘Calendar of Events’ and modification of communication matrix.

a. Clause no. 1.7 ‘Qualification Criteria’ has been amended as given below:

1.7.1	The Bidder should have minimum five years of experience of rendering Manpower services in any Govt. Department / Public Sector Undertaking / any reputed Academy / Private Companies.	This clause has been excluded.
1.7.2	The bidder should have average annual turnover of minimum of Rs. 50 crore in last three financial years. Copy of audited Balance Sheet and P&L Account to be submitted in this regard.	The Average Annual Turnover of the prospective bidder(s) should be equal to or more than Rs. 30 Crores during any three of last five Financial years (i.e FY 18-19 ,FY 19-20, FY 20-21, FY 21-22 & FY 22-23). For MSME registered in the State of Odisha, criteria shall be reduced to 20% of the existing one. Copy of audited P&L Account (with UDIN no.) to be submitted in this regard.
1.7.3	The bidder should have executed similar works (Management of IT Service Desk and Data Centre Operation) for at least in two organizations for a total order value of Rs. 15 Cr during last 3 years. Copy of work order and successful completion certificate from the customer to be submitted in this regard.	Bidder should have experience of having successfully executed similar orders for at least Rs. 9 Crores cumulative during last 5 years. Copy of orders / invoice / completion certificates to be submitted in this regard. Years’ calculation shall be done w.r.t. the date of tender publish.
1.7.4	The Bidder should be either registered as a Company under Companies Act 1956/ 2013 or as a Partnership (including Limited Liability Partnership) under Partnership Act, 1932 as the case may be and should be in existence for not less than five years before 31/03/2023. Bids of Sole proprietorship firms/JV shall not be considered at all.	Bidder shall not be a JV firm and shall submit a self-undertaking in this regard.
1.7.5	The Bidder should have PAN/GST registration number and should filed GST for last 6 months. In this regard bidder has to submit the proof of such payments.	The bidder must have valid GST registration and must submit a copy of the GSTIN certificate in this regard.
1.7.6	The Bidder should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance Acts or any other labour authorities including under the Contract Labour (Regulation and Abolition Act).	The Bidder should possess and submit the following documents: a. Valid EPF Registration Certificate. b. Valid ESI Registration Certificate.
1.7.7	The Bidder or any of its partners/directors etc. should not have been black listed/ debarred by any of the government agencies or department or should not have been found guilty of commission of acts of moral turpitude or convicted for any economic offence or for violation of any labour laws etc by any court or any authority appointed to enforce any labour laws or regulations including by PF/ESI authorities.	Bidder must not be blacklisted by any Govt. Organization / utility within last 5 years against similar nature of work. Bidder must submit self-undertaking in this regard.

1.7.8	The Bidder should have records of satisfactory performance for the project executed during the last three years, as on the date of application. Project wise Customer Certificate is mandatory mentioning the PO No, Work summary and duration on customer letter-head having the customer contact person details.	Certificate of satisfactory performance issued by any Govt. Organisations / Discoms / PSUs / Reputed companies is to be submitted. The work against these issued certificates should be completed in last 07 years from the date of bid submission. In case the bidder has a previous association with Tata Power Discoms for similar products and services, the performance feedback for that bidder by Tata Power's User Group shall only be considered irrespective of performance certificates issued by any third organization.
